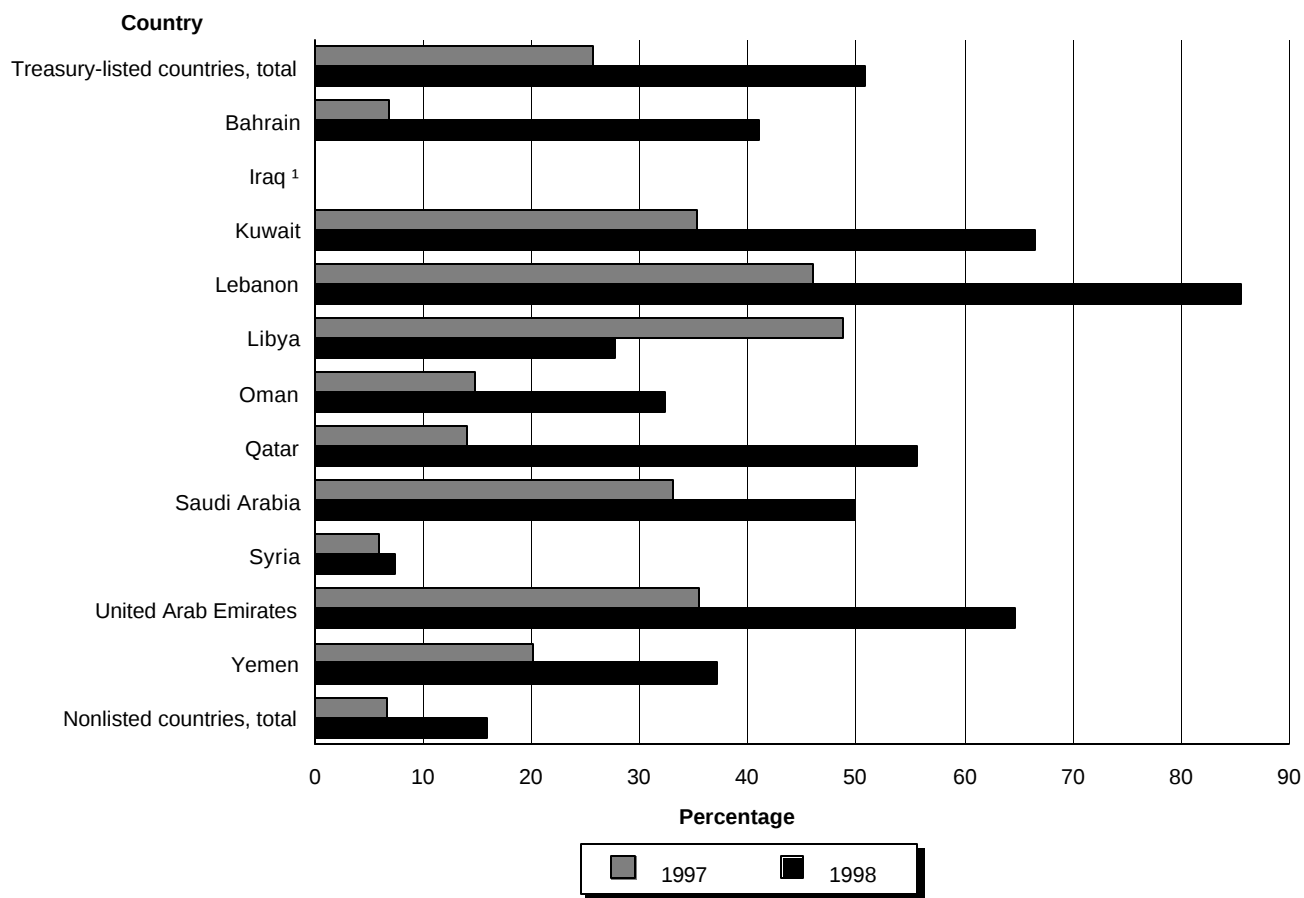


International Boycott Reports, 1997 and 1998

On page 156:

Boycott agreements as a percentage of requests received for Filing Year 1998 are incorrect in Figure A for Oman and Kuwait and the overall total because the number of requests received was overstated for these two countries. The corrected percentages for 1998 for Oman and Kuwait and the total are presented below along with the percentages for 1997 that were previously published.

On pages 159-160:

The number of boycott requests received (column 5) for Filing Year 1998 and boycott agreements as a percentage of requests received (column 10) for Filing Year 1998 for total requests and type 5 requests in Table 1 are incorrect for "All countries," "Treasury-listed countries," "Kuwait," and "Oman." The number of type 5 requests was overstated for Kuwait and Oman. The correct numbers and percentages for the table cells identified are presented below.
